

UNITED KINGDOM * BENEFITS FACT SHEET

* HQ USAF/JAI provides this information to give USAF members a *starting point* for information about individual logistic support (ILS) provided in-country for "unaccompanied" dependents. Unaccompanied dependents are those dependents in-country where the sponsor is NOT assigned. Generally, ILS for dependents staying in-country without the sponsor is ***extremely restricted and limited***. Each country is different, and ILS is often complex and difficult to obtain.

THEREFORE, IN ALL CASES, USAF MEMBERS SHOULD CONTACT THE SERVICING BASE LEGAL OFFICE FOR A TAILORED REVIEW.

NOTES:

1. Space available when dependents are transported to the UK, space required when dependents remain in the UK. Contact your DODDS Regional Fiscal Division for eligibility requirements as outlined in DoD Directive 1342.13. Any child who starts a DODDS school year as an entitled child will be permitted to complete the school year.
2. Base theater only.
3. Normally no duty is imposed if household goods and POV are transported on a Government Bill of Lading. This is at the discretion of the British government.
4. If dependents are approved to reside overseas (in the UK) while the sponsor is performing a 12 month unaccompanied remote tour with follow-on orders to the UK, then the dependents will be allowed full logistic support during that 12 month period. (Sponsor must have follow-on orders to the UK). Similarly, if dependents are residing in the UK with their sponsor and the sponsor is assigned a 12 month unaccompanied remote tour, then, provided the dependents are allowed to remain in the UK during the sponsor's remote tour, the dependents will be allowed full logistic support during the 12 month period. (Follow-on orders back to the UK are not required in this circumstance). The logistical support in both cases is limited to 12 months. Beyond 12 months, see Note 8.
5. Postal privileges will be provided if the sponsor's assignment is to a short tour area. If sponsor's assignment is to the CONUS or an accompanied area, support will not be provided.
6. Dependents residing overseas unaccompanied by their sponsor have no transportation entitlement when referred for medical care except the aeromedical evacuation system.
7. For one year only. After one year, see Note 8.
8. Entitled to tax-paid patronage of U.S. commissaries and exchange. Contact the gaining base legal office in the UK for more information.

Unaccompanied dependents staying for more than 90 days must contact local host nation officials regarding residency permit requirements.
