SUBJECT: Off-Limits Establishments

1. These establishments/areas are declared off-limits to military personnel. If, in any case the name has been changed the premises are still off-limits.

SUBJECT: Off-Limits Establishments

b. Areas.

- (1) All bodies and streams of water on FT Campbell are off-limits for unauthorized water sports and activities.
- (2) All rock quarries, both active and abandoned, within Kentucky and Tennessee are off-limits for all purposes. The only exceptions to this prohibition are:
 - (a) The Cerulean Spring Quarry, Cadiz, Kentucky, may be used for scuba diving only during operating hours.
 - (b) Martha's Quarry, located east of Lebanon, Tennessee may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.
 - (c) Cowan Quarry, located south of Cowan, Tennessee, and may be only used by certified divers and dive students accompanied by a certified instructor. Due to the high cliffs, non-diving recreational use is not permitted.
 - (d) Hopkinsville Diving Quarry, located off exit 9, adjacent Pennyrile Parkway, and 680. Non-diving recreational use is not permitted.
2. Military personnel observed in off-limits establishments are in violation of a lawful general order and are subject to apprehension for violation of Article 92, UCMJ.
3. This off-limits list supersedes the Off-Limits Establishments memorandum dated 10 January 2011.
4. Off-Limits Establishments are prohibited from advertising on the Installation.
