

Chaplains Program Content Guide

The following established style guidelines reflect the longstanding practices of developers and editors of content for the Family Advocacy Program. They are consistent with the rules and guidance outlined in the Associated Press Stylebook and reflective of Office of Military Community and Family Policy style and usage preferences.

Do:

- Pay attention to the overall organization and flow of an article. Information and ideas should be logically organized and there should be some sense of continuity or flow from one idea to the next.
- Avoid redundancy.
- Keep sentences short.
- Use concise language.
- Write in gender-neutral terms, except if appropriate to do otherwise (i.e., gender-specific services/groups).
- Write in relationship-neutral terms such as “partner” or “couple.”
- Write statements and ideas clearly.
- Ensure that subheads reflect the content of the text that follows.
- Focus on the positive side of content as much as possible.
- Keep the wide audience range in mind.
- Use acronyms or abbreviations on second and subsequent uses of program names. For example, use the Chaplains Religious Enrichment Development Operation on first reference and CREDO on all subsequent uses.

Do Not:

- Make assumptions.
- Tell people how they feel.
- Tell people what they should, need to, must, ought to, can’t or won’t do.
- Tell people what they should always or never do.

Formatting:

- Less is more — be concise.

Definitions

Term	Definition
chaplain	A chaplain is a commissioned officer of the Chaplain Corps of the Army, a commissioned officer of the Chaplain Corps of the Navy or a commissioned officer in the Department of the Air Force designated for duty as a chaplain.
chaplain assistant/religious program specialist	A chaplain assistant is an enlisted service member who provides expertise in religious support and general support to the chaplain. They are called chaplain assistants in the Army and the Department of the Air Force, and religious program specialists in the Marine Corps and Navy.
Chaplains Religious Enrichment Development Operation	Also known as the CREDO, this Marine Corps and Navy program offers transformational, retreat-based programs designed to assist service members and their families in developing the personal and spiritual resiliency necessary to excel in a military environment.
command chaplain	In the Army, a command chaplain is a senior chaplain assigned to or designated by a commander of a staff, command or unit. In the Department of the Air Force, a command chaplain is a chaplain in the grade of colonel who is responsible to a major command commander for Chaplain Corps programs and personnel. In the Navy, a command chaplain is the senior chaplain assigned to and designated by the commander of a staff, command or unit.

command religious program	A command religious program is a religious ministry planned, programmed and implemented to meet the religious ministry needs of personnel and other authorized users of a command.
confidentiality	Confidentiality is the act of keeping information given by or about an individual in the course of a professional relationship secure and secret from others.
family members	Family members are individuals whose relationship to the military sponsor leads to entitlements, benefits or privileges by the military services.
family readiness group	A family readiness group is a command-sponsored organization of service members, civilian employees, family members (immediate and extended) and volunteers belonging to a unit. The family readiness group provides mutual support and assistance, and a network of communication among the family members, the chain of command and community resources.
family readiness officer	A family readiness officer is a representative in the Marine Corps who serves as the liaison between the command and families.
joint force chaplain	A joint force chaplain is a military chaplain designated by the joint force commander to serve as the senior chaplain for the joint force.
lay leader	A lay leader is an authorized, trained and command-appointed individual who supports the free exercise of religion by providing a service consistent with their lay status.
Military and Family Support Center	A Military and Family Support Center is a facility on a military installation with the resources and expertise to deliver military family support programs. It may be called Army Community Service, Marine Corps Community Services, the Navy Fleet and Family Support Center or the Airman and Family Readiness Center.
Military Family Readiness System	The MFRS is a network of programs, services, people and agencies, and the collaboration among them, that promote the readiness and quality of life of service members and their families.
Navy Family Ombudsmen Program	The Navy Family Ombudsmen Program is a Navy-wide program primarily executed at the local command that improves mission readiness. Navy ombudsmen serve as both communications links between the commanding officer and command family members and as professionally trained information and referral specialists for the command's families.
Prevention and Relationship Enhancement Program	The Prevention and Relationship Enhancement Program is a service branch chaplain program for service members, spouses and fiances/fiancées that teaches marital/premarital couples some essential skills, including how to communicate effectively, work as a

	team, solve problems, manage conflict and preserve and enhance love, commitment and friendship.
protective factors	Protective factors are conditions in individuals, families or communities that, when present, increase the health and well-being of an individual or family.
religious accommodation	Religious accommodation is the reasonable and good faith effort to support religious requirements of individuals and groups within the boundaries of good order and discipline.
religious advisement	Religious advisement is the practice of informing the commander about the impact of religion on joint operations – including worship, rituals, customs and practices of U.S. military personnel, international forces and the indigenous population.
religious affairs	Religious affairs are the combination of religious support and religious advisement.
religious ministry	Religious ministry is the entire spectrum of professional duties performed by chaplains and chaplain assistants/religious program specialists to provide for or facilitate the free exercise of religion and accommodate the religious practices of military personnel, their families and other authorized personnel.
religious ministry team or religious support team	A religious ministry team or religious support team is comprised of at least one chaplain and one chaplain assistant/religious program specialist to design, implement and execute the unit ministry or religious program. The same team may be called a unit ministry team in the Army.
religious support	Religious support is the chaplain-delivered free exercise of religion through worship, religious and pastoral counseling services, ceremonial honors for the dead, crisis intervention and advice to the commander on matters pertaining to morals, ethics and morale as affected by religion.
wing, garrison or installation chaplain	A wing, garrison or installation chaplain is a senior chaplain assigned to oversee all chapel staff and religious programming at a particular installation or site.
